

THE [HIMGIRI ZEE UNIVERSITY]³ ACT, 2003
[Uttarakhand Act No.17 of 2003] (as amended by Amendment Act No. 03 of 2010 & 03 of 2011)
AN
ACT

A replacing Act of Ordinance No. 04 of 2003 establish and incorporate an University sponsored by TALEEM Research Foundation, Ahmadabad, Gujarat in the state and provided for matters connected therewith or incidental thereto.

It is hereby enacted in the fifty fourth year of the Republic of India as follows:

CHAPTER -1
Preliminary

Short title and Commencement	1.	(1) This Act may be called the [Himgiri Zee University] ³ Act, 2003. (2) It shall be deemed to have come into force on the date the notification is issued by the state Government.
Definitions	2.	In this Act, unless the context otherwise requires— (a) “Academic Council” means the Academic council of the University; (b) “constituent College” means a college or institution maintained by the University; (c) “Council for Technical Education” means the all India Council for Technical Education established under section 3 of the All India Council for Technical Education Act, 1987’ [(d) “Distance Education system” means the system of imparting education with in the State through any means of information technology and communication such as multimedia, broadcasting, telecasting online on internet, other interactive methods, e-mail, internet, computer, e-learning, correspondence course or a combination of any two or more of such means;] ² (e) “Employee” means employee appointed by the University and includes teachers and other staff of the University or of a constituent college; (f) “faculty” means faculty of the University; (g) “prescribed” means prescribed by the Statutes; (h) “Principal” in relation to a constituent college, means the head of the constituent college and includes, where there is no principal, the Vice principal or any other person for the time being appointed to act as principal; [(i) “Regional Centre” means a centre within the State established or maintained, by the University for the purpose of coordinating, supervising the work of Study Centres located in the State and for performing such other functions as may be conferred on such centre by the Board of Management.;] ² (j) “State” means State of [Uttarakhand] ¹ ;

	<p>(k) “Statutes” and “Rules” means respectively, the Statutes and Rules of the University;</p> <p>[(l) “Study Centre” means a centre within the State, established, maintained and recognized by the University for the purpose of advising, counseling or for rendering such other assistance required by the students;]¹</p> <p>(m) “TALEEM Research Foundation” means the sponsoring body of the University which is a registered Charitable Trust and Literary Society at Ahmadabad, Gujarat;</p> <p>(n) “Teacher” means a professor, Associate Professor, Assistant Professor/Lecturer or such other person as may be appointed for imparting instruction or conduction research in the University or in a constituent college and institution and includes the principal of a constituent college, in conformity with the norms prescribed by the U.G.C.</p> <p>(o) U.G.C. means the University Grants Commission established under the University Grants Commission Act, 1956;</p> <p>[(p) “University” means the [Himgiri Zee University]² established under this Act, which shall function within the State of Uttarakhand and shall comply with the orders and guidelines of the University Grants Commission;]¹</p> <p>(q) “Zed Career Academy Centre” means a centre established, maintained or recognized by the University for the purpose of receiving telecast, e-mail, internet, interactive talk back, conducting training, organize lectures, seminars and workshops, advising, counseling or rendering any other assistance required by the students.</p>
<p>CHAPTER-II The University and its Objects</p>	
<p>Proposal for the establishment of the University</p>	<p>3</p> <p>(1) TELEEM Research Foundation shall have the right to establish the University in accordance with the provisions of this Act.</p> <p>(2) An application containing the proposal to establish a University shall be made to the state Government by the TALEEM Research Foundation. The proposal shall contain the following particulars, namely:-</p> <p>(a) The objects of the University along with the details of the TALEEM Research Foundation;</p> <p>(b) the extent and status of the University and the availability of land;</p> <p>(c) the nature and type of programmes of study and research to be undertaken in the University during a period of the next five years;</p> <p>(d) the nature of faculties, courses of study and research proposed to be started;</p> <p>(e) the campus development such as buildings, equipment and structural amenities;</p> <p>(f) the phased outlays of capital expenditure for a period of the next five years;</p> <p>(g) the item-wise recurring expenditure, sources of finance and estimated expenditure for each students;</p>

	<p>(h) the scheme for mobilizing resources and the cost of capital thereto and the manner of repayments to each source;</p> <p>(i) the scheme of generation of funds internally through the recovery of fee from students, revenues anticipated from consultancy and other activities relating to the objects of the University and other anticipated incomes;</p> <p>(j) the details of expenditure on unit cost, the extent of concessions or rebates in fee free ship and scholarship for students belonging to economically weaker sections and the fee structure indicating varying rate of fee, if any, that would be levied on non resident Indians and students of other nationalities;</p> <p>(k) the years of experience and expertise in the concerned discipline at the command of the TALEEM Research Foundation as well as the financial resources;</p> <p>(l) the system for selection of students to the courses of study at the University, and</p> <p>(m) status of fulfillment of such other conditions as may be required by the State Government to be fulfilled before the establishment of the University.</p>
<p>Establishment of University</p>	<p>4. (1) Where the State Government, after such inquiry as it may deem necessary, is satisfied that TALEEM Research Foundation, Ahmedabad has fulfilled the conditions specified in sub-section (2), of section 3, it may direct the TALEEM Research foundation, Ahmedabad to establish an Endowment Fund.</p> <p>(2) After the establishment of the Endowment fund, the State Government may, by notification in the Official Gazette, accord sanction for establishment of the University.</p> <p>[(3) The headquarters of the University shall be at Dehradun, Uttarakhand and it may also have campuses or regional centres, study centres and ZED Career Academy Centres at other places in the State, as may be specified from time to time :</p> <p style="padding-left: 40px;">Provided that the University shall establish one study Centre in each of the thirteen districts of the State within three years of the establishment of the University.]¹</p> <p>(4) [***]²</p> <p>(5) The Chancellor, the Vice-chancellor, members of the Board of Governors, members of the Board of management and the Academic Council for the time being holding office as such in the University so established, shall constitute a body corporate and can sue and be sued in the name of the University.</p> <p>(6) On the establishment of the University under sub-section (2), the land and other movable and immovable properties acquired, created, arranged or built by the University for the purpose of the University except the properties of TALEEM Research foundation, Ahmadabad, shall stand transferred to, and vest in, the University.</p> <p>(7) The land, building and other properties acquired for the University shall not be used for any purpose, other than that for which the same is acquired.</p>

<p>University not to be entitled to financial Assistance</p>	<p>5.</p>	<p>The University shall be self-financing and shall neither make a demand nor shall be entitled to any grant in-aid or any other financial assistance from the State Government or any other body or corporation owned or controlled by the State Government.</p>
<p>No power to affiliate any institution</p>	<p>6.</p>	<p>The University may have constituent colleges, Regional Centres, study Centres and Zed Career Academy centres but shall have no power to admit any other college or institution to the privileges of affiliation.</p>
<p>Objects of the University</p>	<p>7.</p>	<p>The objectives for which the University is established are as follows:-</p> <ul style="list-style-type: none"> (a) To advance and disseminate learning and knowledge by multimedia and other information and communication technology and also conventional means, and to provided opportunities for education to a larger segment of the population and to promote the educational well being of the society in general, to encourage the distance education and alternate learning systems in conjunction with the conventional educational pattern of the country and to co-ordinate and determine the standards in such systems; (b) To benefit the humanity spread all over the country and the world, without any discrimination on the ground of caste, creed, community, gender and religion according to its motto of ‘Vasudhaiv Kutumbakam’ (world as family). The University shall, organize its activities in conventional residential and distance mode to carry out research, teaching and extension work; (c) To develop, design, and teach innovative, flexible professional and technical courses so as to provide best possible education of the highest academic standards and continue to strive to do so by way of peer group and expert evaluation; (d) To offer courses conforming to the prescribed courses recognized by the UGC and AICTE; (e) To provide education, instruction and training in such branches of learning as it may deem fit;

		(f) To encourage and carry out fundamental and applied research for the advancement and dissemination of knowledge.
Power of the University	8.	<p>(1) The University shall have the following powers, viz:-</p> <p>(a) to establish, maintain and recognize such Regional centres and study centres as may be determined by the University from time to time in the manner laid down by the statutes;</p> <p>(b) to carry out all such other activities as may be necessary or feasible in furtherance of the object of the University;</p> <p>(c) to hold examinations for, and to institute grant and confer degrees or other academic distinctions to, and on, persons, who-</p> <p>(i) have pursued a course of study in the University or in a constituent college or under a distant education system at Regional Centres/ Study Centres or Zed Career Academy Centre, or</p> <p>(ii) have carried on research in the University or in a constituent college or under a distant education system;</p> <p>(d) to confer honorary degree or other academic distinctions in the manner and under conditions laid down in the statutes/provisions.;</p>
		<p>(e) to institute and award fellowships, scholarships and prizes etc. in accordance with the statutes;</p> <p>(f) to demand and receive such fees, bills, invoices and collect charges as may be fixed by the statutes or rules, as the case may be;</p> <p>(g) to make provision for the advancement of education in distance and alternate learning systems and other areas mentioned in section 6;</p> <p>(h) to make provision for extra curricular activities for students and employees;</p>

	<ul style="list-style-type: none">(i) to make appointments of the faculty, officers and employees of the University or a constituent college, Regional Centres, study centres and Zed Career Academy centres;(j) to receive donations and gifts of any kind and to acquire, hold, manage, maintain and dispose of any movable or immovable property, including trust and endowment properties for the purpose of the University or a constituent college, or a Regional Centre, study centre and Zed Career Academy centre with the prior permission to TALEEM Research Ahmadabad;(k) to institute and maintain halls and to recognize places of residence for students of the University or a constituent college;(l) to supervise and control the residence, and to regulate the discipline among the students and all categories of employees and to lay down the conditions of service of such employees, including their code of conduct;(m) to create Academic, Administrative and support staff and other necessary posts;(n) to co-operative and collaborate with other Universities in such a manner and for such purposes as the University may determine from time to time;(o) to provide distant education system and the manner in which distance education in relation to the academic programmes of the University may be organized;(p) to organize and conduct refresher courses, orientation courses workshops, seminars and other programmes for teachers, lesson writers, evaluators and other academic staff;(q) to determine standards of admission to the University or a constituent college, regional centres, study centres and Zed Career Academy Centre through specialized committees with the approval of Academic Council;(r) to make special provision for students belonging to the State of [Uttarakhand]¹ for admission in any course of the University or in a constituent college, Regional Centre or study centre and Zed Career Academy Centre;(s) to do all such other acts or things weather incidental to the powers aforesaid or not, as may be necessary to further the objects of the University;(t) to prescribe such courses for bachelor Degree, post graduate, Doctor of Philosophy, Doctor of Science Degrees and Research which would be covered by UGC and AICTE but University shall have right to start diplomas, certificates etc. in its own subjects;

<p>University open to all classes, castes, creed and gender</p>	<p>9.</p>	<p>The University shall be open to all persons irrespective of class, creed or gender:</p> <p>Provided that nothing in this section shall be deemed to prevent the University from making special provisions for admission to students of the state of Uttarakhand :</p> <p>Provided further that nothing in this section shall be deemed to require the University or a constituent college or Regional Centres or Study Centres or Zed Career Academy Centres to admit in any course of study a larger number of students than may be</p>

National / Accreditation	10.	The University will seek accreditation from respective national accreditation bodies.
CHAPTER-III Officers of the University		
Officers of the University	11.	The following shall be the officers of the University:-- (a) the Visitor; (b) the Chancellor; (c) the Vice-Chancellor; (d) the pro vice-Chancellor; (e) the deans of faculties; (f) the Registrar; (g) the Finance Officer; and (h) such other officers as may be declared by the statutes to be officers of the University.
The Visitor	12.	(1) The Governor of [Uttarakhand] ¹ will be the Visitor of the University. (2) The Visitor shall, when present, preside at the convocation of the University for conferring degrees and diplomas. (3) The Visitor shall have the following powers namely:- (a) To call for any paper or information relating to the affairs of the University. (b) On the basis of the information received by the Visitor, if he is satisfied that any order, proceeding, or decision taken by any authority of the University is not in conformity with the Act, Regulations, Status or Rules, he may issue such directions as he may deem fit in the interest of the University and the directions so issued shall be complied with by all concerned. (4) Every proposal for the conferment of an honorary degree or distinction shall be subject to the approval of the Visitor.

The Chancellor	13.	<p>(1) Chairman of TALEEM Research Foundation, Ahmadabad, Gujarat will be the first Chancellor of the University, whose tenure shall be of five years, thereafter TALEEM Research Foundation, with the prior concurrence of the Visitor, would appoint the Chancellor from amongst its trustees.</p> <p>(2) The Chancellor shall have such powers as may be conferred on him by this Act or the Statutes made thereunder.</p>
The Vice-Chancellor	14.	<p>(1) The Vice-Chancellor shall be appointed on such terms and conditions as may be prescribed by the statutes for a term of three years by the Chancellor from a panel of three persons recommended by the committee constituted in accordance with the provisions of sub-section (2).</p> <p>(2) The committee referred to in sub-section (1) shall consist of the following persons, viz:-</p> <p>(a) One person nominated by the Visitor;</p> <p>(b) One person nominated by the Chancellor;</p> <p>(c) The principal Secretary/Secretary to the State Government in the Higher Education Department;</p> <p>(d) Three nominees of the Board of Governors, one of whom shall be nominated as the Governor of the committee by the Board of Governors.</p> <p>(3) The committee shall, on the basis of merit, prepare a panel of names of three persons suitable to hold the office of the Vice-Chancellor and forward the same to the Chancellor along with a concise statement showing the academic qualifications and other distinctions of each person.</p> <p>(4) The Vice-Chancellor shall be the Principal executive and academic officer of the University and shall exercise general supervision and control over the affairs of the University and give effect to the decisions of the authorities of the University.</p> <p>(5) Where any matter other than the appointment of a teacher is of urgent nature requiring immediate action and the same could not be immediately dealt with by any officer or the authority or other body of the University empowered by or under this Act to deal with it, the Vice-Chancellor may take such action as he may deem fit with the prior approval of the chancellor.</p>
		<p>(6) The Vice-Chancellor shall exercise such other powers and perform such other duties as may be laid down by the statutes or the rules.</p> <p>(7) The Chancellor is empowered to remove the Vice-chancellor after due enquiry. It will be open to the Chancellor to suspend the Vice-Chancellor during enquiry depending upon the seriousness of the charges, as he may deem fit.</p>
The Pro-Vice-Chancellor	15.	<p>A Pro-vice-Chancellor may be appointed by the Vice Chancellor with prior approval of the chancellor in such manner and shall exercise such powers and perform such duties as may be prescribed by statutes.</p>
Deans of faculties	16.	<p>Deans of faculties shall be appointed by the chancellor in such manner and shall exercise such powers and perform such duties as may be prescribed by statutes.</p>
The Registrar	17.	<p>(1) The Registrar shall be appointed by the chancellor in such manner and on such terms and conditions as may be prescribed.</p> <p>(2) All contracts shall be entered into and signed by the Registrar on</p>

Other Officers	19.	The manner of appointment, terms and conditions of service and powers and duties of the other officers of the University shall be such as may be prescribed.

The Finance Committee	24.	<p>(1) The Finance Committee shall consist of :-</p> <p>(a) The Vice-Chancellor – Chairman;</p> <p>(b) The Finance Officer</p> <p>(c) Principal Secretary/Secretary to the State Government in the Higher Education Department or his nominee not below the rank of Joint Secretary to the State Government;</p> <p>(d) Such other members as may be prescribed in the statutes.</p> <p>(2) The Finance committee shall be the principal financial body of the University to take care of financial matters and shall, subject to the</p>

Other Authorities	25.	The constitution, powers and functions of the other authorities of the University shall be such as may be prescribed.
Proceedings not invalidated on account of vacancy	26.	No Act or proceeding of any authority of the University shall be invalid merely by reason of the existence of any vacancy or defect in the constitution of the authority.
CHAPTER-V Statutes and Rules		
Statutes	27.	<p>Subject to the provisions of this Act, the Statutes may provide for any matter relating to the University and staff, as given below:-</p> <ul style="list-style-type: none"> (a) the procedure for transaction of business of the Authorities of the University and the composition of bodies not specified in this Act; (b) the operation of the permanent endowment fund, the general fund and the development fund; (c) the terms and conditions of appointment of the Vice-Chancellor, the Registrar and the Finance officer and their powers and functions; (d) the mode of recruitment and the conditions of service of the other officers, teachers and employees of the University. (e) the procedure for resolving disputes between the University and its officers, faculty members, employees and students; (f) creation, abolition or restructuring of departments and faculties; (g) the manner of co-operation with other Universities or institutions of higher learning; (h) the procedure for conferment of honorary degrees; (i) provisions regarding grant of freeships and scholarships; (j) number of seats in different courses of studies and the procedure of admission of students to such courses including reservation of seats for Uttarakhand students; (k) the fee chargeable from students for various courses of studies;

(2) Where the State Government fails to take any decision with respect to the approval of the statutes within the period specified

		under sub-section (1) it shall be deemed to have been approved by the State Government.
Power to amend the Statutes	29.	The Board of Governors may, with the prior approval of the state Government, make new or additional Statutes or amend or repeal the statutes.

Conditions of service of employees	33.	<p>(1) Every employee shall be appointed under a written contract, which shall be kept in the University and a copy of which shall be furnished to the employee concerned.</p> <p>(2) Disciplinary action against the students/employees shall be governed by procedure prescribed in the statutes.</p> <p>(3) Any dispute arising out of the contract between the University and</p>
