## The Uttarakhand University Act, 2012

[Uttarakhand Act No. 11 of 2013]

### An Act

to establish and incorporate a university in the name of Uttarakhand University at Dehradun by Sushila Devi Centre for Professional Studies and Research (A society registered under Societies Registration Act, 1860 at Dehradun) to develop and promote Higher Education, Technical and Professional Education in the field of Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life Sciences, Agricultural Sciences, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Hospitality and Professional Education meaning B.Ed., M.Ed., B.P.Ed., research and training programmes and such other programmes or field declared to be such by Gazette Notification by the Central Government, in consultation with Indian Ayurvedic Council, Indian Dental Science Council, Indian Pharmacy Council, National Teachers Training Council, University Grants Commission, Bar Council of India, Distance Education Council and other regulatory Council related to Profession Education for the award of Diploma, Degree and Research leading to the award of Ph.D., D. Phil, D.Lit., D.Sc. and for matters connected therewith or incidental thereto.

Be it enacted by Uttarakhand State Legislature in the Sixty-fourth year of the Republic of India as follows:--

### CHAPTER-I Preliminary

<b>Short title and Commencement</b>	<b>1.</b>	(1) This Act may be called Uttarakhand University Act, 2012. (2) It shall be deemed to have come into force on such date as the State Government may, by notification in the Official Gazette, appoint.
<b>Definitions</b>	<b>2.</b>	In this Act, unless the context otherwise required :- (a) <b>“Academic Council”</b> means the Academic Council of the University; (b) <b>“Board of Management”</b> means the management board of University; (c) <b>“Bar Council of India”</b> means Bar Council of India Rules made under Advocates Act, 1961; (d) <b>“Board of Governors”</b> means the Board of Governors of the University; (e) <b>“Career Academy Centre”</b> means a centre established, maintained or recognized by the University for the purpose of receiving telecast, e-mail, internet, interactive talk back, conducting training, organize lectures, seminars and workshops, advising, counseling or rendering any other assistance required

	<p>by the students with the prior approval of the State Government;</p> <p>(f) <b>“Chancellor”</b> means the Chancellor of the University;</p> <p>(g) <b>“Campus”</b> means a campus of University maintained and conducted on the basis of regulations by the University;</p> <p>(h) <b>“Constituent College”</b> means a college or institution maintained by the University;</p>
	<p>(i) <b>“Council for Technical Education”</b> means the All India Council for Technical Education established under section 3 of the All India Council for Technical Education Act, 1987;</p> <p>(j) <b>“Distance Education System”</b> means the system of imparting education through any means of information technology and communication such as broadcasting, telecasting, correspondence course, seminar, contact program or a combination of any two or more such means within the state.</p> <p>(k) <b>“Employee”</b> means employee appointed by the University and includes teachers and other staff of the University or a constituent college;</p> <p>(l) <b>“Faculty”</b> means faculty of the University;</p> <p>(m) <b>“Finance Committee”</b> means the Finance Committee of the University;</p> <p>(n) <b>“Government”</b> means the Government of Uttarakhand;</p> <p>(o) <b>“Hall”</b> or <b>“Hostel”</b> means a unit of residence for students maintained or recognized by the University or a constituent college;</p> <p>(p) <b>Sushila Devi Centre for Professional Studies and Research Society</b> means Society registered under Societies Registration Act, 1860 having registered office at Arcadia Grant, P.O-Chandanwari, Premnagar, Dehradun-248007, Uttarakhand;</p> <p>(q) <b>“Prescribed”</b> means prescribed by the Statutes;</p> <p>(r) <b>“Director”</b> of campus or <b>“Principal”</b> in relation to a constituent college, means the Head of the campus or constituent college and includes, where there is no Principal, the Vice-Principal or any other person for the time being appointed to act as Principal;</p> <p>(s) <b>“Registrar”</b> means the Registrar of the University;</p> <p>(t) <b>“Regional Centre”</b> means a centre established or maintained by the University for the purpose of co-ordination and supervising the work of Study Centers in any region and for performing such other functions as may be conferred on such centre by the Board of Management;</p> <p>(u) <b>“State”</b> means the State of Uttarakhand;</p> <p>(v) <b>“Statutes”</b> and <b>“Rules”</b> mean, respectively, the Statutes and</p>

		<p>Rules of the University;</p> <p>(w) <b>“Study Centre”</b> means a centre established, maintained or recognized by the University for the purpose of advising, counseling or for rendering any other assistance required by the students;</p> <p>(x) <b>“Teacher”</b> means a Professor, Associate Professor, Assistant Professor/ Lecturer or such other person as may be appointed for imparting instruction, conducting research in the University or in a Constituent College and includes the Principal of Constituent College;</p> <p>(y) <b>“UGC”</b> means University Grants Commission established under University Grants Commission Act, 1956;</p> <p>(z) <b>“University”</b> means the Uttaranchal University established under this Act ;</p> <p><b>“Visitor”</b> means the Visitor of the University.</p>
		<p><b>CHAPTER-II</b> <b>The University and its Objects</b></p>
<p><b>Proposal for the establishment of the University</b></p>	<p><b>3.</b></p>	<p>(1) Sushila Devi Centre for Professional Studies and Research Society, Dehradun, Uttarakhand, hereinafter referred to as Society shall have the right to establish the University in accordance with the provisions of this Act.</p> <p>(2) An application containing the proposal to establish a University been made to the State Government by the Society. The proposal contained the following particulars; namely:-</p> <p>(a) the objects of the University along with the details of the Society;</p> <p>(b) the extent and status of the University and the availability of land;</p> <p>(c) the nature and type of programmes of study and research to be undertaken by the University;</p> <p>(d) the nature of facilities, courses of study and research proposed to be started;</p> <p>(e) the campus development such as buildings, equipment and structural amenities;</p> <p>(f) the phased outlays of a capital expenditure for a period of the next five years;</p> <p>(g) the item-wise recurring expenditure, sources of finance and estimated expenditure for each student;</p> <p>(h) the scheme for mobilizing resources and the cost of capital thereto and the manner of repayments to each sources;</p> <p>(i) the scheme of generation of funds internally through the recovery of fee from students, revenues anticipated from consultancy and other activities relating to the objects of the</p>

		<p>University and other anticipated incomes;</p> <p>(j) the details of expenditure on unit cost, the extent of concessions or rebates in fee, free ship and scholarship for students belonging to economically weaker sections and the fee structure indicating varying rate of fee, if any, that would be levied on non resident Indians and students of other nationalities;</p> <p>(k) the years of experience and expertise in the concerned discipline at the command of the Society as well as the financial resources;</p> <p>(l) the system for selection of students to the courses of study at the University; and</p> <p>(m) status of fulfillment of such other conditions as may be required by the State Government to be fulfilled before the establishment of the University.</p>
<p><b>Establishment of University</b></p>	<p><b>4.</b></p>	<p>(1) Where the State Government, after such inquiry is satisfied that Society has fulfilled the conditions, norms and requirements for establishments of Uttaranchal University, hence a University to be known as Uttaranchal University is established.</p> <p>(2) The University shall be body corporate by the name Uttaranchal University and shall have a perpetual succession and a common seal and shall sue and be sued by its name.</p>
		<p>(3) (a) The Headquarter of the University shall be at Dehradun, Uttarakhand. The University can open its additional campus, regional centres, study centres from time to time as per requirement provided the norms of UGC and other statutory bodies are followed. The University may open its second campus with in the State after five years with the approval of the State Government. However the University may open additional campus any time in hilly region located at an altitude greater than 2500 feet;</p> <p>(b) However, to establish new faculties where additional land would be required as per norms of the concerned regulatory body, the University shall establish a split campus either adjoining or nearby within Dehradun.</p> <p>(4) The Chancellor, the Vice-Chancellor, members of the Board of Governors, members of the Board of Management and the Academic Council for the time being holding office as such in the University so established under sub section (2) shall constitute a body corporate and can sue and be sued in the name of the University.</p> <p>(5) On the establishment of the University under sub-Section (2) the land and other movable and immovable properties acquired, created, arranged or built for Law College, Dehradun, Uttaranchal Institute of Technology, Uttaranchal Institute of Management and Uttaranchal Institute of Business Studies by the</p>

		<p>Society shall vest in the University.</p> <p>(6) The available land, building; various Department/faculties of the University shall be must according the standard of Apex Regulatory Bodies.</p> <p>(7) The land and building should be available with the private University as per the norms of Apex Regulatory bodies for different courses separately.</p>
<b>University not to be entitled to financial assistance</b>	5.	The University shall be self-financing and shall neither make a demand nor shall be entitled to any grant in-aid or any other financial aid from the State Government or any other body or corporation owned or controlled by the State Government.
<b>No Power to affiliate any institution</b>	6.	The University may have Constituent Colleges, Regional Centre, Study Centre, Research Centre and Career Academy Centre within State after prior approval of State Government/UGC after five years of establishment of University but shall have no power to admit any other college or institution to the privileges of affiliation.
<b>Effect of the Establishment of the University</b>	7.	<p>On and from the date of commencement of this Act :-</p> <p>(1) Any reference to Law College Dehradun affiliated to Hemwati Nandan Bahuguna Central University, Srinagar Garhwal; Uttaranchal Institute of Technology, Uttaranchal Institute of Management and Uttaranchal Institute of Business Studies affiliated to Uttarakhand Technical University and Hemwati Nandan Bahuguna Central University, Srinagar, Garhwal in any contract or other instrument shall be deemed as a reference to Uttaranchal University, established under this Act;</p>
		<p>(2) Every person employed in Law college Dehradun, Uttaranchal Institute of Technology, Uttaranchal Institute of Management and Uttaranchal Institute of Business Studies immediately before the commencement of this Act shall hold his office or service in Uttaranchal University established under this Act by the same tenure, at the same remuneration and upon the same terms and conditions with the same rights and privileges as to leave, provident fund and other matters as he/she would have at the same if this Act have not been enacted and shall continue to do so unless and until his/her employment is terminated or until such tenure, remuneration and terms and conditions are duly altered by the Statutes :</p> <p>Provided that if the alteration so made is not acceptable to such employee, his employment may be terminated by the University in accordance with the terms of the contract with the employee or, if no provision is made therein on this behalf, on payment, to him by the University, of compensation equivalent to</p>



		<p>three months remuneration in case of permanent employees and one month remuneration in case of other employees :</p> <p>Provided further that every person employed before the commencement of this Act, pending the execution of a contract shall be deemed to be appointed in accordance with the provisions of a contract consistent.</p>
<b>Objects of the University</b>	<b>8.</b>	<p>(1) The objectives for which the University is established are as follows :-</p> <p>(a) to advance learning, disseminate knowledge and provide provisions for teaching, training in the fields of Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life Sciences, Agricultural Science, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Hospitality, and Professional Education meaning B. Ed., M. Ed., B.P.Ed., research and training programmes and such other programmes or fields declared to be such by Gazette Notification by the Central Government, in consultation with Indian Ayurvedic Council, Indian Dental Science Council, Indian Pharmacy Council, National Teachers Training Council, University Grants Commission, Bar Council of India, Distance Education Council and other regulatory Council related to Professional Education for the award of Diploma, Degree and Research leading to the award of Ph.D., D.Phil., D.Sc. and for matters connected thereto;</p> <p>(b) to establish campuses, constituent colleges of Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life Sciences, Agricultural Science, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Hospitality, and Professional Education meaning B.Ed., M.Ed., B.P.Ed., research and training programmes and such other programmes or field declared to be such by Gazette Notification by the Central Government, in the consultation with Indian Ayurvedic Council, Indian Dental Science Council, Indian Pharmacy Council, National Teachers Training Council, University Grants Commission, Bar Council of India, Distance Education Council and other regulatory Council related to Professional Education for the award of Diploma, Degree and Research leading to the award of Ph.D., D.Phil., D.Sc. and for matters connected thereto conforming to the prescribed courses recognized by the UGC and AICTE reserving the right to start other Degree, Diploma and certificate course in furtherance of its objectives;</p> <p>(c) to develop, design and teach innovative, flexible professional and technical courses so as to provide best possible education of the highest academic standards in the fields of Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life</p>

	<p>Sciences, Agricultural Science, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Hospitality and Professional Education meaning B.Ed., M.Ed., B.P.Ed., research and training programmes and such other programmes or field declared to be such by Gazette Notification by the Central Government, in consultation with Indian Ayurvedic Council, Indian Dental Science Council, Indian Pharmacy Council, National Teachers Training Council, University Grants Commission, Bar Council of India, Distance Education Council and other regulatory Council related to Professional Education for the award of Diploma, Degree and Research leading to the award of Ph.D., D.Phil., D.Sc. and for matters connected thereto comparable to global standards;</p> <p>(d) to advance and disseminate learning and knowledge by multimedia and other information and communication technology and also conventional means, and to provide opportunities for education to a larger segment of the population and to promote the educational well being of the society in general, to encourage the distance education and alternate learning systems in conjunction with the conventional educational pattern of the country and to co-ordinate and determine the standards in such systems.</p> <p>(e) to establish constituent centre for distance education and continuing education programmes as given in clause (b) above.</p> <p>(f) to set up campus out of the State, with the consent of UGC and the concerned State Government;</p> <p>(2) To establish Research and Development centre to promote, Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life Sciences, Agricultural Science, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Professional Education meaning B.Ed., M.Ed., B.P.Ed., research and training programmes and such other programmes or field declared to be such by Gazette Notification by the Central Government, in consultation with Indian Ayurvedic Council, Indian Dental Science Council, Indian Pharmacy Council, National Teachers Training Council, University Grants Commission, Bar Council of India, Distance Education Council and other regulatory Council related to Professional Education for the award of Diploma, Degree and Research leading to the award of Ph.D., D. <p><b>Powers and Duties of the University</b></p>	<p>9.</p>	<p>The University shall have following powers and duties; namely-</p> <p>(1) to provide for instruction in such branches of learning as the University may think fit with particular emphasis on modern subjects aiming at becoming centres of excellence in each such areas, and to make provision for research for the advancement and dissemination of knowledge;</p> <p>(2) (a) to carry out all such other activities as may be necessary or feasible in furtherance of the object of the University.</p> <p>(b) to confer degrees or other academic distinction and establish grants, conduct examination for such persons: -</p> <p>(1) to hold examinations for, and to institute grant and confer degrees or other academic distinctions to, and on, persons, who-</p> <p>(2) to pursue a course of study in the University or in a Constituent College;</p> <p>(3) to confer honorary degree or other academic distinctions in the manner and under conditions laid down in the Statutes/provisions;</p> <p>(4) to institute and award fellowships, scholarships and prizes etc. in accordance with the Statutes;</p> <p>(5) to demand and receive such fees, bills invoices and collect charges as may be fixed by the Statutes or rules, as the case may be;</p> <p>(6) to make provisions for extra curricular activities for students and employees;</p> <p>(7) to make provisions for promotion of education in the field of Engineering, Architecture, Technology, Communication, Environment, Law and Legal Education, Management, Computer Application, Life Sciences, Agricultural Science, Applied Sciences, Social Sciences, Humanities, Arts, Commerce, Medicine, Dentistry, Para-medical, Pharmacy, Journalism, Mass Communication, Bio-Technology, Marine Sciences, Petroleum Studies, Energy Studies, Solar Energy, Hotel Management and Hospitality, and Professional Education meaning B. 		<p>(11) to supervise and control the residence, Hostels and to regulate the discipline among the students and all categories of employees and to lay down the conditions of service of such employees, including their Code of Conduct;</p> <p>(12) to create academic, administrative, managerial and support staff and other necessary posts;</p> <p>(13) to co-operate or collaborate with other Universities in such manner and for such purposes as the University may determine from time to time;</p> <p>(14) to provide distance education system and the manner in which distance education in relation to the academic programmes of the University may be organized.</p> <p>(15) to organize and conduct refresher courses, orientation courses, workshops, seminars and other programs for teachers, lesson writers, evaluators and other academic staff;</p> <p>(16) to determine standards of admission to the University or a Constituent College, Regional Centre, Study Centre, Career Academy Center with the approval of Academic Council;</p> <p>(17) to make special provision for students belonging to the state of Uttarakhand for admission to the courses of the University or in a Constituent College, Regional Centre, Study Centre, Research Centre and Career Academy Centre;</p> <p>(18) to do all such other acts or things whether incidental to the powers aforesaid or not, as may be necessary to further the objects of the University;</p> <p>(19) to prescribe such courses for Engineering, Architecture,</p>

Phil., D.Sc. and provide for matters thereto.</p> <p>(20) to clearly set apart Academic Activities of the University from the activities the society;</p> <p>(21) to provide for the preparation of instructional materials, including films, cassettes, tapes, CD, VCD, and other softwares;</p> <p>(22) to recognize examinations of, or periods of study (whether in full or in part) at other Universities, institutions or other places of higher learning as equivalent to examinations or periods of study in the University and to withdraw such recognition at any time;</p>
	<p>(23) to raise, collect, subscribe and borrow with the approval of the Governing Body whether on the security of the University, money for the purpose of the University;</p> <p>(24) to enter into, carry out, vary or cancel contracts.</p> <p>(25) to appoint on contract or otherwise visiting Professors, Emeritus Professors, Consultants and such other persons who may contribute to the advancement of the objects of the University.</p> <p>(3) Notwithstanding anything contained in any other law for the time being in force but without prejudice to the provisions of sub-section (1) and (2), its shall be the duty of the University to take all such steps as it may deem fit for the promotion of the Open University and distance education system and for the determination of standards of teaching, evaluation and research in such system and for the purpose of performing this function, the University shall have such powers, including the power to allocate and disburse grants to colleges, Regional Centers and Study Centres and Career Academy Centres, whether admitted to its privileges or not or to any other University or institution of</p>

		higher education learning, as may be specified by the Statutes.
<b>University Open to all Classes, Castes, Colour, Creed and Gender</b>	<b>10.</b>	<p>The University shall be open to all persons irrespective of class, caste, colour and creed or gender :</p> <p>Provided that nothing in this section shall be deemed to prevent the University from making special provisions for admission to students of the State of Uttarakhand :</p> <p>Provided further that nothing in this section shall be deemed to require the University or Constituent Colleges or Regional Centre, Study Centre and Career Academy Centre to admit in any course of study a larger number of students than may be determined by the Statutes.</p>
<b>National Accreditation</b>	<b>11.</b>	The University will seek accreditation from respective national accreditation bodies.
		<b>CHAPTER-III</b> <b>Officers of the University</b>
